

## Secretariat Assurance Statement 2026

<p>I understand who else the secretariat members work for and their external responsibilities.</p>	<p>The secretariat members work exclusively for not-for-profit cross-party think tank Policy Connect, which provides the secretariat for 6 APPGs. Beyond their secretariat work, Policy Connect staff undertake research, events and communications activities in the policy areas: accessibility; education and skills; industry, technology and innovation; health; and sustainability.</p>
<p>I know whether the secretariat members are paid or remunerated, and if so, by whom.</p>	<p>Secretariat staff are remunerated by not-for-profit cross-party think tank Policy Connect.</p>

<p>Where a group, charity, company, etc, is providing or finding the secretariat, I know how that entity is funded.</p>	<p>Policy Connect is funded by a combination of regular annual membership subscriptions and time-limited sponsorships, and grant funding. Policy Connect receives support from around 100 organisations from industry, academia and the third sector and declares all funders in bands <a href="#">on its website</a>. Policy Connect undergoes an independent financial audit each year. Policy Connect is also on the Register of Consultant Lobbyists in accordance with specialist guidance for organisations that provide secretariat services</p>

	to All-Party Parliamentary Groups (APPGs) and provides <a href="#">quarterly returns</a> about its funders to the register.
